- It has also inquired the controlling shareholder – Banco do Brasil – and received the following statement:

“BANCO DO BRASIL S.A. (BB), informs that no decision was taken within the scope of its governance in relation to its subsidiary, BB Seguridade Participações S.A., as provided for in art. 2 of CVM Resolution 44/21, which should have been disclosed to the market.”

The Company reaffirms its commitment to best practices regarding the disclosure of relevant information about its business, pursuant to the regulations in force, including, but not limited to, CVM Resolution 44/2021, the Novo Mercado of B3 Regulation and its policy of Disclosure of Material Act or Fact, remaining at your disposal for any further clarification that may be required.
